#### **Business Arising:**

- 1. Decision taken to purchase 100 stackable plastic side-tables for use principally at Tasmanian Festival of Bridge.
- 2. Decision taken to continue our subscription to Pianola Plus on behalf of our members.
- 3. Building inspection occurring on 2 May with general building repairs to follow. The building problems all relate to the subsidence of the land on which the clubrooms are built.
- 4. Bridge for Brain to be held at TBA on Friday 4 May with Table monies and donations to be forwarded to Neuroscience Research Australia.
